Mid-Atlantic Chapter Society for the Preservation of Old Mills

October 14, 2017 Semiannual Meeting

Location:Agricultural and Industrial Museum, York, PAAttendees:See Attachment A

President Dan Campbell called the meeting to order at 1:55 P.M.

Minutes of the April 22, 2017, meeting at Newlin Grist Mill in Concordvile, PA, were approved as distributed.

Finance: The beginning balance in the treasury as of April 15 was \$9503.80. Since then there have been receipts of \$23,241 and Expenses of \$16095.95, mostly attributable to the chapter's work in hosting the 2017 SPOOM national conference. Not all meeting expenses and income are reported to date. See Attachment B for a detailed report. Final Year-end financial reports are available on the SPOOM-MA website. Craig Sansonetti agreed to again perform the annual audit for 2017.

Membership: Current paid memberships include 52 chapter/SPOOM (\$10), 11 chapter/non-SPOOM (\$15), 24 sustaining memberships (\$25), and 12 organizational memberships (\$50) for a total of 99 members.

Old Business

2017 SPOOM Conference: Organizing the conference was the primary activity of the chapter in the most recent period. The conference is now successfully completed.

Chapter By-Laws: The revised chapter by-laws were posted for review by the membership on May 30 and submitted for vote on July 14. Votes were cast by 40 members, all in favor of approving the revised bylaws, which were adopted and took effect on July 30, 2017.

Chapter Status: Bob McLaughlin reported that the chapter's application for incorporation in Pennsylvania has been completed and submitted. He expects the incorporation to be complete in about 6 months.

Liability Insurance for Officers: A quote of Directors and Officers Insurance has been obtained and is being reviewed by Judy Grove and Dan Campbell. No action was taken.

Possible Website Changes: Judy Grove moved that the chapter retain Face Websites as the SPOOM-MA web provider for another year and pay \$499 to upgrade the site for a more modern interface. The motion was seconded by Laurie Sieminski. Megan Orient suggested that we defer the upgrade and investigate switching to another provider. She pays \$200 annually and believes she gets superior functionality. Judy Grove noted that we pay Face Websites quarterly and can cancel our service at any month. After further discussion the original motion was voted upon and adopted.

New Business

SPOOM Conference Planning Guide: Judy Grove moved that our chapter form a committee and allocate \$1000 for expenses and to compensate a paid Project Coordinator to compile a SPOOM National Conference Meeting Handbook. Staff of our current conference and hosts of previous conferences would be asked to feed information to the Project Coordinator who would prepare a draft of the handbook and obtain feedback from the committee. The final product will be a Meeting Handbook in both electronic and hard copy form. The motion was seconded by Megan Orient. After brief discussion the motion was approved by majority vote with one vote in opposition.

Mill Entrepreneurship Training: Judy Grove reported that Dale Weed, who has a commercial milling business in New England, would like to offer entrepreneurial training through SPOOM as part of the Miller Training program. She believes such a program has the potential to bring new people and funds into SPOOM. Judy Grove moved that SPOOM-MA offer to host a pilot Miller Entrepreneur Training Workshop, details to be worked out later with Dale Weed. The motion was seconded by Susan Langley and adopted unanimously.

Future SPOOM Mid-Atlantic Meetings: Roger Steyaert will be the primary organizer for the Spring 2018 meeting to be held at Burwell-Morgan Mill in Millwood, VA, from March 22 through March 24. The hotel will be the Best Western in Winchester, VA. Mill tours are planned for Thursday and Friday tentatively including Giles Mill, Aldie Mill, and Melgrove Plantation. Saturday will include a visit to Locke's Mill, which is being organic certified, with return to Burwell-Morgan for lunch and the chapter meeting.

Sites for meetings beyond the spring of 2018 have not been confirmed, but the following are under consideration:

- Patapsco River Mill Tour to be organized by Beth deFrancis-Sun (Fall 2018)
- Mills along Jones Falls with possible guided tours by Megan Baco of Preservation Maryland to be organized by Ivan Lufriu and Union Mills (Spring 2019)
- Double Mills, Mardela Springs, MD (Stephanie Elliot, Sylvia Bradley)
- Whitehall Historical Preservation Society can provide meeting site but no operable mills in vicinity (Jeff Donat, Robert Miller))
- Cyrus McCormick Farm and Workshop (including McCormick's Mill), Staunton, VA

Rudolph Hershey Mill Bag Collection: Ivan Lufriu reported that Rudolph Hershey has donated his collection of 60 vintage mill bags from many different mills to SPOOM-MA. Judy Grove believes that Hershey would not mind having the chapter sell the collection with proceeds to support chapter activities. Craig Sansonetti suggested that it would be better to keep the collection intact rather than having it dispersed to many private collectors. Jean Sansonetti suggested that those bags that are significant to an existing mill might be given to that mill. A list of the bags in the collection would be helpful. Bob McLaughlin proposed that the chapter could own the collection and loan out individual bags or the entire collection to mills for display. It was agreed that we should talk to Rudolph Hershey to better understand his intentions in giving the collection to the chapter before deciding how to proceed.

SPOOM National Conference Surplus: Judy Grove noted that there will likely be a surplus when all revenues and expenses for the recent SPOOM conference are recorded. She suggested that the surplus be passed on to the host of next year's conference. Tony Shahan suggested that the chapter board make a recommendation to the members at the 2018 spring meeting. There was general consensus to follow this suggestion.

The meeting adjourned at approximately 3:00 P.M.
